Terms and conditions:

A.1. Work Scope: The supplier agreed to carry out supply, installation, testing 350 KVA generator (Tempest Brand made in UK).

A.2. Generator details with price schedule: The detailed generator specification and price scheduled is referred to suppliers offer (CWPL-AM/0116/16-R01F)

A.3. PRICE: Beyond the above mentioned price schedule BDT.33, 00,000.00 (excluding VAT & AIT) in words –Thirty Three lac only. If required any more related work the buyer will make payment according to the reference quotation.

A.4. Delivery & Completion of Work: 2nd Party is bound to deliver, install, testing and commissioning the generator the said site of first party the same according to the condition of agreement.

Schedule of payment:

The agreement is done for the supply, installation and commission of 1 piece of 350 KVA (prime) Generators.

1. BDT 33, 00,000.00 will be paid before delivery



Warranty:

The supplier shall provide warranty of their equipment's against any manufacturing materials & workmanship defect for a period of 12 (Twelve) months or 1500 hrs which ever comes first with free of servicing cost from the date of commissioning, subject to non repairing / dismantling of equipment without suppliers consent. Warranty does not cover for the consumable items like filters and battery supplied with the generator.




