- e. You are to carry the items/ goods at your own and unloading is to be made by you at your own convenient.
- f. After supplying the goods is to be checked as per invoice by our engineer/ store personnel, if any item is found broken, damage is to be replaced promptly.
- g. Complete supply/ delivery, installation & commissioning would be done within 30 days.
- h. Delivery schedule is to be followed strictly.
- i. If it is delayed to complete the work 1% of total bill will be deducted as penalty for each day delay.

Warranty:

You are to provide replacement warranty for 1 (One) Year from the date of commission/installation and operation and after sales service for 1 year without any service charge.

The above terms and conditions shall remain unchanged and the first party holds the right to insert any other terms & conditions as disclosed in the work order.
