1. The Bank will open LC in equivalent foreign currency against Pro-Forma Invoice supplied by Cross World for:
 - i. GBP 324,238.00 (BDT 33,396,514.00 @ BDT 103) in favour of our partner in UK for generators set;
 - ii. EURO 135,550.00 (BDT 1,21,99,500.00 @ BDT 90) in favour of our partner in Germany for BBT; and
 - iii. EURO 27,500.00 (BDT 24,75,000.00 @ BDT 90) in favour of our partner in Italy for transformers.
2. The Bank will pay BDT 29,928,986.00 (Total Price BDT 7,80,000.00 less Foreign LC value BDT 48,071,014.00) against local letter of credit to be issued by your Bank in favor of Cross World;
3. The import documents and necessary papers (Bank VAT Registration Certificate, IRC, Trade License, etc) shall be provided to Cross World so that the shipment could be cleared by Cross World appointed service providers and carried to your project site. The duty, taxes, C&F fees, related receiptable charges and carrying charges (from chittagong port to your project site) shall be disbursed by Jamuna Bank directly to the respective authority and vendor as per advice of Cross World;
4. Cross World will provide 3 years warranty for supplied equipments; and
5. The origin of by-pass switch shall be Siemens partner FNG/CNYH, Europe.
