

| 01 | Place of delivery   | : | NRB Bank Ltd., A. H. Munshi Tower" (1st floor), Rahima Nagar Bazar, Kachua, Chandpur.  |
| 02 | Specification       | : | The work shall have to be done strictly in accordance with and as per specifications provided in your quotation.   |
| 03 | Date of delivery    | : | You shall complete delivery, installation and commission of the generator at the designated place of the branch within 10(Ten) days from the date of receipt of work order or written communication. So, you are requested to chalk-out your plan to meet the deadline. Delivery shall be made on our demand at your risk and responsibilities. Time overrun shall not be allowed under any circumstances.   |
| 04 | Price escalation    | : | No claim for price escalation will be entertained against the aforementioned job.  |
| 05 | Mode of payment     | : | a) 90% payment will be made after completion of successful installation and commission of the generator.<br>b) Rest 10% will be kept as security money, that shall be released after 1(one) year from the date of successful commission of the generator.  |
| 06 | Penalty             | : | As per work order, if you fail to supply the ordered item within the stipulated time as per Work Order, a penalty @Tk.5, 000.00 only per day delay will be imposed and which shall be deducted from your final bill.   |
| 07 | Warranty            | : | You shall provide warranty for the supplied generator as per your offer with spares and services.  |
| 08 | After Sales Service | : | During warranty you shall provide us regular preventive maintenance service on quarterly basis, apart from our call for service at our Rahima Nagar Branch, Kachua, Chandpur free of cost except consumables (like lube oil, air, fuel and mobile filters required for servicing shall be borne by respective branch at actual). After warranty, a service level agreement (SLA) will be executed on mutual understanding.   |
