- **8.Load Testing**: Continues 8 hours load testing shall have to be conducted at Buyers premise at different load in presence of Buyer's representative. Seller shall have to establish the declared Fuel consumption of the DG.
- 9. <u>Control function check</u>: All Critical Control function checking by "Simulation system".
- 10. <u>Test certificate</u>: Official Certificate of Load Test, Fuel consumption and Control function to be issued by Allam marine Ltd. before shipment.
- 11. Flashing Light Error Alarm on Engine: Flash Light error indicator and Error Code chart to be provided by Allam marine Ltd.
- 12. Sound Alarm : Audio Alarm for error condition to be provided.
- 13. <u>Engine Warranty</u>: 24 months from the date of Commissioning by Seller. This warranty to cover service, repair, replacement etc., as the case may be free of charge within reasonable time.
- 14. Price: The price of the DG is as mentioned in Sellers PI/Indent (GBP: 32,500).
- 15. Payment: By Letter of Credit, 100% at sight on document presentation.

16. LC Terms & Conditions:

- a. LC will be opened by Buyer(Astech Ltd).
- b. LC charges, cost, expenses, Customs duty etc. shall be borne by Buyer (Astech Ltd).
- c. Maximum one amendment charge shall be borne by Buyer. If more than one amendment is required the Sellers beneficiary **Allam marine Ltd.** shall bear the amendment and incident charge.
- d. All bank charges with in Bangladesh on Buyer account& All overseas bank charges on Beneficiary's account.LC currency shall be US dollar.

Once LC opened, no change of any commercial terms & conditions will be allowed.

17. Perkins Engine Serial Number:

- a. Perking Engine serial number has to be provided by Perkins factory and CROSS WORLD POWER LIMITED will confirm the Engine number before shipment and submit a document as evidence thereby.
- b. Individual certificate of origin (COO) is required for major components such as Engine, Alternator, ECU etc. All these components should have name plate mentioning "Made in USA".
- 18.Delay Delivery: Penalty shall be applied at the rate of Tk.10,000 for each day of delay from the stimulated shipment date in the Pl/Indent.

Last time the shipment was delayed.

This time any delay will not be accepted by Buyer & penalty has to be bear by Seller.

19.Shipment/Delivery:

- a. Load test to be conducted prior shipment and certificate should send Buyer immediately.
- b. Shipment of the DG shall be from UK & this has to mentioned in LC and BL. Evidence to this effect be submitted by Seller Cross world Ltd.
- 20.Installation & Commissioning: The DG shall be installed by Seller within(3 three) working days of arrival of the DG unit at Astech premises. Total work will be coordinated and supervised by Astech Technical team & Astech Technical Head Mr. Mamunur Rashid.
- 21. <u>Manuals</u>: Following Manuals to be supplied by Allam marine Ltd. before shipment of the DG:
- a) Engine Manual in English (includes operating Manual & Maintenance Manual).
- b) Alternator Manual in English.
- c) ECU Manual in English(operation Manual)
- d) Control Panel manual in English(operation Manual).

- 26.Extended warranty: a.Should the buyer so desires, Seller shall provide maintenance service even after completion of warranty period for further 2(two) years.
- b. Top Overhaul will be provided by Cross world Ltd. after 2000 running hours.
