1. Applicable Rates :

You must deliver and commission the generator to the Manager of Proposed Muksudpur Branch, Dohar, Dhaka **within 17.06.2017**. Machine IDs, model numbers and date of commissioning are to be mentioned in the delivery challan/commissioning report. Without signature of the concerned Manager of the branch with a note of satisfaction, the delivery challan or commissioning report will not be acceptable for paying bills.

3. Submission of undertaking :

You will have to submit an undertaking stating that

- The entire specifications as you have mentioned in your tender along with the identification/ serial numbers of generator, alternator, engine etc.
- The generator(s) you will supply will be as per specifications and country of origin.
- Your foreign Principal authorized you to market/sell/maintain the specified generators in Bangladesh.

- d. You have enough worth to compensate any losses if incurred and has sufficient skilled engineers/technicians to serve/maintain/attend any calls for any trouble of the generator within 6-hours within Dhaka City & within 12 hours at any place of the country outside Dhaka.
- e. You will maintain 2 (two) year's warranty/guarantee at free of cost and provide necessary services and original spares parts after a certain duration at the quoted rate up to 1000 hours of operation from the date of commissioning.
- f. The specifications and information provided by you are true and in case of any deviation, you will undertake all responsibilities and you will have no objection if the bank forfeit the security money or any other valid dues payable to you or the Bank may take any legal proceedings at any time within 1000 hours of operation after successful commissioning of your generator.

4. Payment of bill :

You have to submit bill with Original Mushak-11 Challan after successful commissioning along with a note of satisfaction/ certificate mentioning, Generator's brand, model, capacity, identification/serial numbers of the generator, engine & alternator, supplier's name, date of commissioning etc from the Branch Manager.

5. Performance Security:

10% (ten percent) of the entire bill amount will be retained as performance security for 1 (one) year from the date of successful commissioning of the Generator.

Management has the rights to cancel this work order or bring any change in this work order without showing any reason whatsoever.
