- **B. Delivery Schedule:** Gen set with ATS should be delivered within 7 days from the date of 1st payment (Gen set will be delivered 3/12/2017 and ATS will be delivered 8/12/2017).
- C.1. PRICE: Total price for 01 nos Generator is BDT 9, 85,000.00 (Nine lack Eighty Five Thousand Only) is agreed by the First Party.
- **C.2. Payment Terms:** First Party agreed to pay BDT 7,38,000.00 as an advance through Pay Order Cheque No: 1917111 Dated: 30/11/2017 at the time of Order confirmation and balance payment BDT 2,47,000.00 will be paid through a PDC of 2 months later from the date of 1st cheque Cheque No: IBV 1047479 Dated: 30/01/2018.

Warranty:

As per standard of manufacturer, we provide 3000 hours or 2 year warranty whichever comes first, effective from the date of delivery at the client's premises. Our warranty policy is for any manufacturing defects or any premature wear & tear due to usage. The faulty part(s) is/are replaced/repaired within the warranty period. However, Warranty doesn't cover improper maintenance by the user, consumable items, servicing by unauthorized person, running the genset above its capacity or any unauthorized modification of the genset

Services:

The supplier or Second Party will provide **2 years / 3000 hours** free service support for the above mentioned Generator Set from the date of commissioning, within this period, the First Party or buyer will pay only the cost of consumable items like lube oil, coolant, battery electrolyte and all kinds of filter items.

Installation & Commissioning:

The price quoted here includes Installation & Commissioning charge provided the genset is installed in Basement or at Ground Floor level. However, this offer does not include the cost of commissioning materials, such as, Power/Control Cable, Lube Oil, Coolant, Diesel, Civil works, Ducting, Manual labor, Silencer pipe Extension Work, & any other materials that may be necessary for installation of the generator set.
