- Applicable taxes will be deducted at source as per BD. Govt. rules.

#### 4. BANK GUARANTEE:

The Supplier must provide Bank Guarantee total amount of 15% of total PO value with two (02) years validity effective from generator delivery & installation date.

#### 5. REFERENCE:

This is a repeat order in reference of earlier PO no. (ref. SCL/Crossworld/20170522/451 dated: 22nd May 2017).

#### 6. LD CLAUSE:

The goods & services are to be delivered at the place specified above within above mentioned delivery date, failure of which liquidated damage @ 2% per day subject to a maximum ceiling of 10% of the total PO value shall be levied.

#### 7. WARRANTY:

The Supplier shall provide replacement warranty for two (02) year from the date of installation.

#### 8. HEALTH & SAFETY ISSUE:

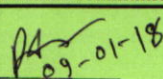


#### 9. CONFIRMATION OF ACCEPTANCE:
