Sub.: Work order for Supply, Installation, Testing and Commissioning of 01 (one) unit Prime 30 KVA/Standby 33 KVA Rating TEMPEST Brand Diesel Generating Set with Foreign Automatic Transfer Switch (ATS) and Foreign Sound Attenuated Canopy for Urban Light project.

With reference to your Revised Offer Ref.: CWPL-AM/3059/17-R01 dt. 12th February 2018 and subsequent discussions and understanding with Engr. Md. Moshir Rahman, Asst. General Manager, Sales and Marketing, Cross World Power Ltd. (CWPL), we are pleased to issue the work order for supplying, installation, testing and commissioning of 01 (one) unit 30 KVA / 33 KVA (Prime/Standby) TEMPEST brand (Manufactured by Allam Marine Ltd., UK) Diesel Generating Set (Model # PS30) completed with Foreign Automatic Transfer Switch (ATS) and Foreign Sound Attenuated Canopy (85 dBA @ 1 meter), having PERKINS brand Engine (Model # 1103A-33G origin U.K.), Stamford brand Alternator (Model # P144G, Origin U.K.), DEEP SEA (U.K.) brand Control Module, Country of Origin – United Kingdom (U.K.) and Port of Shipment – Felixstowe port / Any port, U.K. for Urban Light Project at House # 27, Road # 117, Block – CES(C), Gulshan Model Town, Dhaka.

You are therefore requested to complete all necessary arrangements and legal formalities for delivery, installation, testing and commissioning of the above mentioned Diesel Generating Set for Urban Light Project at House # 27, Road # 117, Block – CES(C), Gulshan Model Town, Dhaka immediately from your ready stock.

Work Order Value: a) The Total price for supplying, installation, testing & commissioning of the above mentioned Diesel Generating Set completed with foreign built ATS and Canopy is Tk. 9,50,000/= (taka nine lac fifty thousand) only including AIT.

- b) AIT will be deducted at source as per prevailing Govt. rules and AIT Chalan will be provided to you for your record/tax file. AIT will be [@ 4% of Tk. 9,50,000/-] i.e. Tk. 38,000/- (taka thirty eight thousand) only which will be deducted from price at the time of payments.
- c) Cross World Power Ltd. will have to pay VAT and provide us with original VAT Challan (as per prevailing Govt. rules) at the time of delivery of the consignment to the project site.

Payment: a) 1st Installment - being the amount Tk. 3,80,000/- (taka three lac eighty thousand) only including AIT, will be paid at the time of issuing Work Order. Deduction of AIT being the amount Tk. 15,200/- (taka fifteen thousand two hundred) only [@ 4% of Tk. 3,80,000/-] will be made from 1st Installment at the time of payment.

b) 2nd Installment - being the amount Tk. 2,85,000/- (taka two lac eighty five) only including AIT, will be paid immediate after delivery of the complete consignment of Generator set to the project site. Deduction of AIT being the amount Tk. 11,400/- (taka eleven thousand four hundred) only [@ 4% of Tk. 2,85,000/-] will be made from 2nd Installment at the time of payment.

c) 3rd Installment - being the amount Tk. 2,85,000/- (taka two lac eighty five) only including AIT, will be paid 8 (eight) weeks after successful installation, testing, commissioning of the Generator Set. Deduction of AIT being the amount Tk. 11,400/- (taka eleven thousand four hundred) only [@ 4% of Tk. 2,85,000/-] will be made from 3rd Installment at the time of payment.

We would appreciate your immediate action in this regard.
