Mode of Payment :

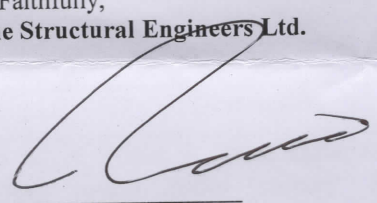
1. 50% of total amount shall be paid to you along with the workorder.
