4. Transportation on goods delivered destination must be prepaid.
5. Purchaser shall have the right to make changes in the order but no additional charge will be allowed unless authorised in writing by Purchaser. If such changes affect delivery or the amount to be paid by Purchaser, Supplier shall notify Purchaser immediately and negotiate an adjustment.
6. It is Supplier's responsibility to furnish the quantity specified. In this order or in any Purchase Order Release issued in connection there with. No variation in quantity will be accepted as compliance with same. Purchaser serves the right to return excess shipments at Supplier's expense.
7. Acceptance of this Order by Supplier shall normally be contemporaneous with and upon the date of Purchaser's written Acknowledgement Commencement of work upon this Order by the Supplier constitute acceptance failing such written acknowledgement.
8. The contract resulting from acceptance hereof cannot be modified except by a writing/ modification of PO.
9. All matters connected with this order and performances thereof shall be construed, interpreted, applied and governed in all respects by the law of Bangladesh.
