- 01. The supplier shall deliver within 14 March 2019 after receiving the work order. In case, the supplier fails to deliver the goods in time, then a penalty will be imposed.
- 02. Supplier needs to receive the goods back at his own expenses, if rejected for non standard specifications.
- 03. 10% will be paid as advance. 80% payment will be made upon satisfactory erection & commissioning report by KFG Engineering Department from site by 30 days after delivery.
- 04. Final payment 10% will be made through A/C payee Cheque after 2 months upon satisfactory Operation & Service Report by KFG Engineering Department.
- 05. Installation & Commissioning works will be completed by the supplier free of cost. Installation Commissioning and Testing of the Generator would be completed within 3 (three) working days from the date of delivery.
- 06. **Warranty/Guarantee**: 3000 hours of running or 2 year warranty whichever comes first, effective from the date of installation & commissioning at site. If any manufacturing defect or any premature wear & tear is detected due to usage then the faulty part(s) shall be replaced/repaired by the supplier within the warranty period. However, Warranty does not cover improper maintenance by the user, consumable items, servicing by unauthorized person, running the Generator above it's capacity or any unauthorized modification of the Generator.



- 07. The price includes VAT, TAX, Carrying, Loading, Unloading, Installation & Commissioning charge. The Generator will be installed in Basement or on Ground Floor level & does not include the cost of commissioning materials, such as, Power/Control Cable, Civil works, Ducting, Manual labor, Extension Work & any other materials that may be necessary for installation of the Generator.
- 08. Spare parts, after Sales Service & AMC:

Cross World Power Limited will maintain sufficient stock of spare parts at hand to meet regular repair & maintenance demands. Service engineers are always kept ready 24 Hours irrespective Friday/Holidays to meet emergency service to ensure uninterrupted power of the 650KVA Generator set. On-call service is also available to meet any type of emergency.

- 09. Supplier must visit the site for inspection of the technical details.
- 10. A technical team of KFG should per-inspect the product.
- 11. Training: Necessary Training for technical persons will be provided by Cross World Power **Limited** free of charge at the time of commissioning of the 650KVA Generator.
- 12. Standard Items:
