- 2. BBL will deduct all applicable withholding Income Tax and VAT at source at the time of payment as per Government rules
- 3. Warranty: 3000 hours or 2 year warranty whichever comes first, effective from the date of delivery at the premises.
- 4. Delivery: Delivery lead time is 12 working days or as per site requirement.
- 5. Each party hereto agrees to indemnify, defend and hold harmless the other from and against any claim, action, proceeding, damage, liability, fine, penalty, cost and expense (including, without limitation, the reasonable fees and expenses of counsel and the costs of investigation and settlement) arising from any actual or alleged action or omission of the indemnifying party. The first party agrees to indemnify, defend and hold harmless BBL from and against any claim, action, proceeding, damage, liability, fine, penalty, cost and expenses (including, without limitation, the reasonable fees and expenses of repairing) arising out of its act, omission or negligence under this agreement.
- 6. Terms of Payment: 90% of the Total amount will be paid after successful delivery at the site and subsequent submission of the Bill with original challan, copy of Purchase order, installation certificate, which is duly singed by the authorized person of BBL. Rest 10%, will be paid after successful running for three months. Payments will be made through BRAC Bank Account only.
- 7. Bank reserves the rights to call for all relevant papers e.g. production, import, etc.; for further clarification & or settlement of bill.
- 8. Bank shall have the liberty to impose any such penalty to recover their losses if in any case the contractor fails or refuse to deliver the product/services (as applicable) after issuance of Purchase order. Penalty shall be adjusted from any outstanding amount due. In all cases Bank's decision shall be final and conclusive. Bank shall have the right to delist or black list the contractor upon its discretion.
- 9. This price included 3XFree Servicing (without consumable items) for 1 year.
- 10. If sub-standard quality is provided, the Bank reserves the right for outright rejection of the goods, which you will take back at your own cost and will replace with acceptable quality within 5 (Five) days of the rejection date.
- 11. BRAC Bank Ltd. will deduct the actual amount in case of any damages of the Bank's premises during delivery period.
- 12. If sub-standard quality is provided, Bank reserves the right for outright rejection of the goods, which you will take back at your own cost and will replace with acceptable quality within 05 days of the rejection date. If the item & or service provided by the vendor is not to up to the promised mark & despite several attempt vendor fails to match that, the Bank reserves the right to reject the product & or service. At so the Bank will realize any Bank's financed amount that has been wasted due to such event (i.e. construction work, time, manpower implemented, etc.) which shall be adjusted from any outstanding amount due. In all cases Bank's decision shall be final and conclusive.
- 13. Bank has the right to cancel the order anytime for the non-compliance of any Conditions mentioned above.
