## TERMS & CONDITIONS

1. AIT and VAT is included with the quoted price as per Government Rules
2. Supply of imported items will be verified from the drawing.
3. Local works payment shall be as per measurement.
4. Rate includes Custom Duty & Custom Clearance.
5. Pre-Shipments inspection at manufacture's factory for three people.
6. All required tools, tester & any other equipment required for installation, carrying & commissioning will be procured & managed by Cross World Power Ltd .
7. All the related civil works will be taken care by Dhaka Convention Centre whenever required.
8. Final measurements will be made as per practical measurements.
9. Utility services will be arranged by Dhaka Convention Centre till main meter. Further it has to be organized by the vendor following the safety & security measures.
10. Material specification and BOQ as per tender Dated 25<sup>th</sup> Oct 2018.
11. Govt & Miscellaneous cost regarding the load sanction purpose will be paid by Dhaka Convention Centre. All necessary coordination with concern authority will be the responsibility of Cross World Power Ltd.

12. Cross World Power Ltd will be responsible for safety & security of their workers & supervisors.

## Payment Schedule.

- 5% of the total work order value will be released in advance along with Work Order as mobilization advance against Bank Guaranty.
- 15% of the total work order value will be released after two months or Design approval from concern authority whichever is later against Bank Guaranty.
- All related import items LC will be opened by Cross World Power Ltd time to time to complete the project as scheduled.
- 25% of the total work order value will be released after delivery of Transformer & Generator at Site.
- 20% of the total work order value will be released after delivery of BBT & AVR at Site.
- 25% of the total work order value will be released after completion of entire equipment installation at site or 6 months whichever is later.
- 5% of the total work order value will be released after successful handing over of the project.
- Remaining 5% will be retained as security deposit & will be released after 12 months from the date of handing over of the project.

**Time Schedule:** 5 months 20 days (170 Days) from the date of work order, Subjected to completion of civil work & payment release as per schedule. Delay of project handing over will cause penalty of 200,000 (BDT) per week to Cross World Power Ltd.


**Warranty & Service:** Cross World Power Ltd will provide 01 (One) year warranty & free maintenance from the date of handing over of the project.

## Training:


Necessary in country training for operator and machine will be provided by Cross World Power Ltd free of charges.
