Subject: Purchase Order for Supply, Installation, Testing and Commissioning of Bus-bar Trunking (BBT) System for Package 3a - Academy Building & Senior School (PO#31)

With reference to your quotation received via email dated 12th May 2019 (attached herewith as Annexure A) and our subsequent meeting held on 13th May 2019 at project site office, Aga Khan Foundation (Bangladesh), hereinafter referred to as Purchaser, is pleased to place an order with your company, hereafter termed as the Contractor, for the supply, installation, testing and Commissioning of items listed in the Annexure A at the below stated terms and conditions.

Contract Price : **BDT 2,600,000.00/-** (Taka Two Million Six Hundred Thousand Only)

Note:

- The above quoted price is excluding VAT and including AIT. (Quoted unit rates are applicable only for the Academy Buildings and Senior School Building)
- The actual amount of AIT will be deducted from the final Invoice and copy of AIT payment will be provided to the Contractor.
- BBT equipment [EAE, Turkey] shall be delivered directly from the Cross World Warehouse.

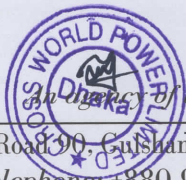
1. Material Specifications and Details

All BBT equipment should be supplied in accordance with approved Tender Drawings provided by the Purchaser (Refer to Annexure B) and specifications & details provided by the Purchaser. (Refer to Annexure A), subjected to approval from the Engineer/Purchaser.

2. Delivery Time

The materials shall be delivered at the construction site of Aga Khan Academy, Dhaka within the 60 calendar days from the date of signing of Purchase Order and Installation, Testing and Commissioning shall be completed within 30 days from the delivery of materials. (Purchase Order shall be effective from the date of signing and valid till issuance of the performance certificate after completion of the warranty Period of one year).

3. Payment Terms

100% of Materials Cost of BDT 2,400,000 shall be paid once the materials has been tested to our satisfaction and delivered at the specified time and satisfied quality.

Second payment of BDT 180,000 shall be paid after installation, testing and commissioning of the BBT system.

Final Payment of BDT 20,000.00 shall be released after completion of one-year warranty period.

The payment shall be made through bank transfer, to the Contractor's bank account, within a period of 30 (thirty) days from the date of invoice submission (In order to shorten the payment processing time, Contractor can submit invoice along with Bill of Lading (B/L Copy) along with necessary backup details such as deliver notes, inspection approvals etc., subjected to approval from the Engineer/Purchaser. **The rates, once agreed, shall not be changed during the duration of the supply period.**

4. **Duties and Taxes**

The Contractor shall be responsible for the payment of all duties and taxes, excluding VAT from the point of purchase up to the delivery point. The Purchaser is exempt from VAT and a copy of the VAT Exemption Certificate shall be provided to the Contractor for information and record.

AIT shall be paid by the Purchaser based on the final Invoice value and the same amount shall be deducted from the Contractor's payment. A copy of the original document of actual AIT payment shall be provided to the Contractor for information and records.

5. **Packing & Supply**

The Contractor shall be responsible for the proper packing, stacking, safe transportation and loading and unloading of all BBT Equipment's at the Construction site.

6. **Installation**

The Contractor shall be fully responsible for the submission of detailed shop drawings for approval prior to the production and proper installation of BBT Equipment in accordance with the drawings, specifications and full satisfaction of the Purchaser. The required site measurements to be taken by the Contractor before fabrication of any Items which are part of this purchase order and no variation will be entertained due to the site measurement/site condition. Site facilities such as temporary storage space for the materials shall be provided by the Purchaser at the site. However, Contractor is fully responsible for the delivered materials until completion of the installation and handover to the Purchaser.

The Contractor is responsible for the proper coordination with the other contractors on site during the execution period.

7. **Warranty**

The Contractor shall provide warranty for 12 Months from taking over Date as well as manufacturer's test certificate from the source that confirms the quality, durability and specifications of the supplied BBT. In case, any defects are discovered in the supplied materials during the delivery or installation, the Contractor shall be obliged to replace such materials in the shortest possible time, to the satisfaction of the Purchaser and at Contractor's own risk and cost.

8. **Force Majeure**

The terms and conditions as agreed here regarding payment and delivery dates shall only be waived in case of Force Majeure which covers war, invasion, rioting, fire, political disturbances, natural disaster or any other act that could not have been foreseen by either party.



9. **Language & Law**

This Purchase Order is signed in the English language and shall be governed by the Laws of Bangladesh.

10. **Timing**

In case, Contractor fails to deliver and install in time, the Purchaser reserves the right to cancel the Purchase Order and to purchase the same material, in part or in whole, from another Contractor, at the Contractor's risk and cost. The Contractor shall not be entitled to any payments in such case.

11. **Order of Precedence**

In case of any discrepancy or contradiction between the Quotation and this Purchase Order, the PO shall prevail.
