Reference to above mentioned subject, we would like to inform the following decision regarding MEP installation of JBL Tower;

1.0 M/s CWPL to be done 1-set of solid copper HDDB wire of earth lead of 2X2/0 SWG in 38mm dia GI pipe from ground floor Earth Electrode (near water body) to Lift machine room along BBT duct as per the Item schedule no. 17.3 This will be completed within 06th June'2019 for "Special Earthing of Lifts"

2.0 Similarly M/s Cross World Power Ltd will be done 1-set of equi-potential Earth Bar of size 100mmX20mmX600mm complete in all respect at Lift Machine room near to BBT duct wall of 2'-6" above from floor as per the Item schedule no. 17.4.3. This will be completed within 06th June'2019

3.0 The installation work of BBT system up to MCC-panel room(Roof-Top) to be completed in co-ordination with representative of M/s Aziz & Company Ltd within 06th June '2019

4.0 Earth Resistance of Earth Electrodes to be measured in presence of MEP Supervision Engineer, JBL Project Manager, Creative's site Engr's etc. This is requested to CWPL for immediate feedback Magger Result of Earth Electrodes". This to be done by TODAY (26th June'2019)

5.0 Representative of CWPL confirmed that "Demand Note for Load Sanction from DESCO will get on 30th June'2019 & positively to be handed over to JBL.
