a)	Place of delivery	:	NRB Bank, Purbachal Branch at Brammankhali (Habib Nagar) Near Kanchan Bridge, Rupganj, Narayanganj	
b)	Delivery Responsibility	*	Cross World Power Ltd. (CWPL) shall take the entire responsibility of supply, installation, testing and commissioning. No third party will be engaged in this job. At the designated place of the branch as per requirement of the Bank subject to readiness of the premises. You are requested to chalk-out your plan to meet the dead line without fail. The delivery will be made on our demand at your risk and responsibilities. Time overrun shall not be allowed under any circumstances.	
c)	Warranty	:	The vendor shall provide 24 (Twenty Four) months from the date of commissioning or 3000 running hours whichever occurs earlier.	
d)	After Sales Service	;	First servicing will be after 50 hours, second servicing will be after 200/250 hours and so on. Quarterly (every months) servicing for the generator within the warranty period apart from our call for service and obt acknowledgement from the respective branch. After warranty, a service level agreement (SLA) will be execut on mutual understanding.	
e)	Responsibility	:	From commencement to completion of work CWPL shall be solely and wholly responsible for any damage to property, loss of life or any other damage or accident and the owners shall bear absolutely no responsibility, in case such incidents occur.
