

- Supplier needs to submit invoice/bill along with all necessary documents to IIEI&H along with original PO copy. Payment instruments will be handed over in next available payment date after the end of credit period.
- Any demurrage or penalty paid for suppliers fault will be deducted from their invoice.
- Price of AMC for year 3 and onward to be added with the existing AMC for Generator.
- If supplier fails to comply with the terms and conditions of this purchase order IIEI&H reserves the right to cancel it.
- Site Preparation: Cross World will survey and suggest the design of civil work, base/site will construct by IIEI&H own cost.
- Delivery & Installation: Delivery to be made from ready stock and installation, testing & commissioning will be completed by the Engr. of Cross World after preparing the base.
- For installation work: For required materials cost (i.e cable, cable tie, cable lux, silencer pipe, pipe jacketing, boring 120 feet with copper wire & earthing bar or any related materials) will provide by IIEI&H.
