- 2. **Delivery:** Delivery should be made within (15 working day from the date of contact agreement) 09th January, 2020.
- 3. **Installation, Testing & Commissioning:** Installation, Testing & Commissioning should be done by supplier before (7 working day subjected to availability of all installation/materials at site) 18th January, 2020.
- 4. Transit Risk: The supplies will bear full responsibility for carrying of materials and all costs expenses such as loading, unloading and transportation from factory to the mentioned site shall be on account of the supplier, at the time of delivery of the generator any damage to the goods in transit will be supplier's responsibility.
- 5. Termination: Runner Properties Ltd. reserves the right to reject merchandise if the supplier failed to execute the contract within the stipulated time and as per specification. If supplier failed to supply within the above mentioned time then this work order will be cancelled automatically.
