1.0 The above price of each item shall include:

- (b) Safety Packaging up to delivery at site.
- (c) VAT and AIT.

2.0 Date & Place of Delivery:

The above machine shall be delivered at Grameen Eye Hospital, Kadamtola Bazar, Rasulpur, Satkhira Sadar, Satkhira within **30 days after receiving the supply order**. You shall have to notify this office at least 24 hours before the delivery of the article at site, so that we can inform our office accordingly.

3.0 Warranty:

Warranty period of the above mentioned Generator shall be 18 (eighteen) month from delivery or 12 month/1500 running hour from commissioning.

4.0 After sales service :

You will also be responsible to provide after sale services (end of the warranty period) as and when required on payment basis after the warranty period.

5.0 Packaging:

The items shall be delivered with proper packaging and protection of international standard. You will ensure us to avoid all kinds of rusts, damages, scratches on the articles.

6.0 Guarantee of quality:

You shall have to ensure that the above articles are Intact, brand new, unused and complies all respects with the quality, specifications and performance as stipulated in your offer letter and also in this Supply Order.


7.0 Vat Tax :


