 - The offer of the Supplier (Ref No: CWPL-AM/3573/19-R01F, DATE : Feb 11, 2020) & Catalogue of the Generator.
2. The Supplier shall supply the generator within 5~15 working days or on call by the Purchaser at Purchaser's site after receiving the advance & pre-delivery payment. Subsequently, the commissioning shall be done. Commissioning shall be done within 10 (Ten) working days provided all inputs are given ready from the Purchaser's side.
3. **Mode of Payment:** TK. 50,000.00 (Fifty Thousand) as advance and rest TK. 9,76,000.00 (Nine Lac Seventy Six Thousand) before taking delivery of Generator.
4. **Warranty:** 24 months from the date of Delivery or 2000 running hours whichever occurs earlier, as per Manufacturer's standard warranty.

5. **Installation:** The price mentioned here including installation supervision charge if the installation place is any where in Bangladesh as per CWPL standard, but the scope of work will be exclude the civil works, fuel, manual labor, material cost
 6. **After Sales Service:** After sales service is free for the mentioned warrantee period without consumables like Filters, Lube oil etc. First servicing is recommended after 50 hours. Second servicing after 200/250 hours or 6 months (which one comes first) and so on (depending up on the site conditions).
 7. Any dispute, controversy or claim arises out of or relating to this contract shall be settled by mutual arbitration.
- This contract shall come into force legally when it is signed by both the parties.
