- Date of delivery or completion of work will be counted from the date of Work Order received/ acknowledged either by signing the photocopy of Work Order or by e-mail confirmation whichever is earlier.
- 5. In case, Bank does not receive the acknowledgement within 02 days, it will be treated that you [Supplier] have accepted all the terms & conditions of the work order. Bank also holds the full right to cancel the Work Order at any time without showing any reason whatsoever.

- 6. In the event of supply of the mentioned items, if the said items does not match with as per requirement/approved quotation then the Bank reserves full right of outright rejection of the items, and the supplier will have to take back the supplied items at their own cost and will have to replace the said items with acceptable condition within the time frame as mutually agreed-upon by the Bank and the Supplier.
- 7. In case of any technical or financial damage or any kind of damage thereof in regard to the supplied goods and/or properties either owned (i.e. supplier) or others means during the time of delivery or commissioning, complete compensation has to be borne by your [Supplier] company unconditionally and to be settled within 15 (fifteen) days positively.
- 8. The product must be supplied as per specification mentioned in quotation. If any change, you [Supplier] will have to consult with the General Services Division, Head Office of the Bank.
- 9. In case of deviation from the quality and specification and/or delay in supply, bank preserves full right to reject the materials and cancel the work order without showing any reason (at your own cost and responsibility).
- 10. In case of any deficiency in the delivered product, you [supplier] will have to make necessary rectification the same immediately at your [Supplier] own cost on receipt of complain.
- 11. No additional bill/work will be entertained without prior permission of the concerned Division.

12. Payment:

- a. Bill should be submitted along with Work Order and Delivery Challan and performance certificate signed by the Branch Authority.
- b. Price includes delivery, installation and commissioning charges.
- VAT, AIT & other Govt. charges will be deducted from your [supplier's] bill as per latest Govt. Circular.
- d. Necessary Tax will be deducted from your bill as per latest Govt. circular and VAT to be applied if you failed to provide Treasury Challan Copy.
- e. Payment will be made only through Payment Order or transfer to your account if lying with Midland Bank Ltd.
- 13. Penalty: In case of failure to complete the task within the stipulated time, from for each subsequent day,0.25% penalty (of W/O value) will be imposed. This will be deducted from the billing amount. If this exceeds 7 (Seven) days from the scheduled time, Bank contains full authority to cancel the work order without notice and forfeit the entire billing amount from the work done by you [supplier] due to your [Supplier] failure to supply the mentioned item.
