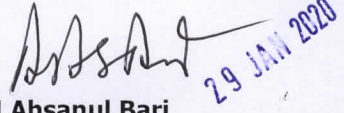

We refer to our yesterday discussion regarding the work order of 3 nos. diesel generators for Novella (80KVA), Casa Divina (80KVA) and Monreve (65KVA) projects. As per our discussion the following MOU has been obtained. Please find the MOU as under:

MOU

01. Cross world will import the above 3 nos. generators with ATS from UK on behalf of Sanmar with their (CWPL) latest import.
02. Sanmar will provide additional GBP. 600.00 (Six hundred) for 3 nos. generators to Cross world as freight charges.
03. Now the total work order value will be GBP. 22,600.00 instead of GBP. 22,000.00 at C&F Chattagram.
04. Cross world will release the generator and deliver to Sanmar site from CTG. Port. provided all other terms and conditions has been complied by Sanmar.
05. Sanmar will pay 25% advance at the time of L/C opening of CWPL and balance 75% upon submission the port documents to Sanmar but not later the goods clear from the port.
06. Currency conversion will be applicable of the bank rate at the payment date.
07. Sanmar will pay additional 14.3% of the order value to cross world for L/C opening charge, Custom duty, ATV, VAT, C&F, BL and other expenses for the LC related cost.
08. If Sanmar fail to pay the payment in time, CWPL will clear the goods from port and bring it to their warehouse, in that case after clearing the full payment, Sanmar has to take delivery from CWPL warehouse Dhaka to their own cost.

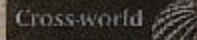
