1) Material: All good and services are to be supplied according to the descriptions/specifications given in the price & technical offer. All Circuit breakers smust have to be-Brand: ABB, Origin: Made in Italy(ABB china or any other country will not be accepted). Supplier will provide the all proven documents of imported item such as origin of circuit breaker, Transformer test report, Manufacturer certificate of Transformer, Shipping documents of port, L/C documents, Bill of lading etc.

2) Delivery: 150 days from the date of acceptance of this work order and realization of advance payment & drawing approval.

3) Challan: Challan in triplicate shall be submitted at the time of delivery of materials. One copy will be returned after acknowledgement of receipt of materials and the company will retain other copies.

4) Installation, ELB Permission and Commissioning: All related installation works to be carried out by the supplier in order to get ELB permission within 30 days from the date of delivery and 45 days require for Final HT connection (from overhead line) from material delivery date. The supplier shall be solely responsible to engage sufficient nos. of skilled Engineer & skilled technician to meet the time schedule. Load sanction and DESCO related works are not included in this work-order. However, supplier shall provide support where necessary.

5) Warranty & After Sales Service: 12 months warranty from date of commissioning only except LA, DOF & HRC Fuse (for all components & spare parts).

6) Road cutting: Road cutting permission is Aakash Developments Ltd. part. HT cable laying from pole/outside to our project & LT cable laying and other formalities have to be done by the suppliers. HT cable laying work have to be done within 03 (Three) days after providing road cutting permission.

7) Transit Risk: The supplier will bear full responsibility for carrying of materials loading, unloading and transportation from factory above mentioned project. If require to the test of transformer from MIST then that transportation cost, loading & unloading paid by client. Any damage of the goods in transition will be Supplier's responsibility.

8) Termination: Aakash Developments Limited, reserves the right to cancel the work order if the supplier failed to execute the contract within the stipulated time frame and as per specifications. If the supplier fails to meet the above terms and conditions Aakash Developments Limited has every right to impose penalty against sole discretionary power of Aakash Developments Limited management.

9) Transformer Test: Aakash Developments Limited will do the following test of Transformer (if require) from MIST in presence of the concern person of 1st & 2nd parties. All the processing work for test will be arranged by both parties and the amount of money will be paid by buyer. Transformer will only be accepted after the satisfactory test result getting from the lab.

(a) Measurement of no load loss and no load current.

(b) Measurement of impedance voltage and load loss.

(c) Dielectric withstands test (High voltage test) & any other test (If require)

3rd installment : 40% will be paid after substation installation, earthing, H.T & L.T cable laying and after getting the ELB certificate (within 7 days).


4th installment : 10% will be paid after final HT connection (within 30 days).
