Summit Alliance Port Limited (SAPL) scope is to provide power cable and supply of all earthing materials for 1 set earthing and labor cost with necessary site preparation which is mandatory for its installation & commissioning.
- 03. Challan: Challan in triplicate shall be submitted at the time of delivery of materials. One copy (Duplicate) will be returned after acknowledgement of receipt of materials and the company will retain other copies.
- 04. Transit Risk: The supplies will bear full responsibility for carrying of materials and all costs expenses such as loading, unloading and transportation from Dhaka to the mentioned site shall be on account of the supplier at the time of delivery of the Generators. Any damage to the goods in transit will be Supplier's responsibility.
- 05. Termination: Summit Alliance Port Limited reserves the right to reject merchandise if the supplier failed to execute the contract within the stipulated time and as per specification. If the supplier fails to meet above terms and conditions SAPL has every right to impose penalty against sole discretionary power of Cross world management.

01. Mode of Payment:

- a) 10% Amount will be paid along with work order as a booking money.
- b) 70% Amount will be paid before supply Materials.
- c) Rest 20% Amount will be paid after successfully installation and commissioning the Genset.
- d) Vat challan will be submitted by supplier at the time of delivery & AIT will be deducted from bill.

Delivery: Generator Sets will be delivered to the site within January 25, 2021.

Warranty/Guarantee:
