This deed of agreement entered on this 21<sup>st</sup> March 2021

**BETWEEN**

Mr.Faysal Ahmed, Mr.Mumazzad Ahmed & Dr.Mr.Mutahar Ahmed, Plot-05, Road-11, Sector-06, Uttara, Dhaka-1230, Here represented by their attorney **Prof. M A Wahid** of House-20, Road-01, Sector-06, Uttara, Dhaka-1230, herein after referred to as the First Party (Which expression shall unless excluded by or repugnant or contrary to the context be and deemed to mean and include their heirs, executors, administrators, legal representatives, assignees etc.

**AND**

**CROSS WORLD POWER LIMITED**, Plot-1/B, Road-90, Gulshan-02, Dhaka-1212 referred to as the Second Party which expression shall unless excluded by or repugnant or contrary to the context be and deemed to mean and include their successors in in interest, administrators legal representatives, assigns etc

**WHEREAS**

- The First Party is desirous of purchasing a 45 KVA Diesel Generating Set from the Second Party and had several meetings, discussions and telephonic talks with them and finally arrived at a decision to purchase the said generator from the Second Party at a total cost of BDT 9,50,000 (Nine Lac Fifty Thousand Taka Only) including local canopy & local Auto Transfer Switch (ATS) of the generator at the premises of the First Party as mentioned above.
- The Second Party is a company dealing in import, supply, and supervision of installation and commissioning of such Generator of Tempest Brand of UK origin in the desired space of the purchasers with supply of spare parts etc as and when required on payment basis.

Now, therefore, this memorandum of understanding witnessed and it is hereby mutually agreed by and between the parties here to as follows.

1. That the second party will supply a brand new 45 KVA Diesel Generator (Model: PS45, Engine Perkins and alternator Stamford) with local canopy and local Auto Transfer Switch from ready stock including transportation, loading unloading supervision of installation & commissioning, without commissioning materials.  
All the components Engine (Perkins), Alternator (Stamford) & Control module (Deep Sea) will be made in UK.
2. The cost of generator has been arrived at BDT 9,50,000 (Nine Lac Fifty Thousand Taka Only) after negotiation all inclusive with local canopy & ATS and commissioning under the supervision of the second party and duly monitored by the first party as refer to the second party's quotation ref. no CWPL-AM/0564/21 Date on Feb 25, 2021.
3. **Delivery:** The time limit for supply of the Generator at site is on or before 45 working days from the date of this deed of agreement.
4. **Payment Terms:**
  - a. Advance: BDT 1,00,000/-
  - b. After submission of shipping and Quality/Compliance documents: BDT 3,80,000/-
  - c. After DG inspection at CWPL warehouse: BDT 3,80,000/-
  - d. After Installation (within 15 days): BDT 90,000/-
