

Kindly be noted that, as per the meeting with HURDCO on 2nd Jan'2021, they agreed to compensate 100,000 Taka for cancelling the WO of 400 KVA Electrical Substation, confirmed by the below mail from HURDCO.

HURDCO had given advance amount of Taka 499,000 against the substation and this compensated 100,000 taka will be deducted from the given advance amount. The rest amount BDT 399,000 from advance amount to be shifted as advance payment of 150 KVA Generator that HURDCO has given order to CWPL in separate WO.
